



## Training course IUCLID Scip notification

### Background

Regulation EC 1907/2006 (REACH) introduced a candidate list of Substances of Very High Concern. If a substance from this SVHC list is present in an article over 0.1% w/w, REACH article 33 requires suppliers of those articles to inform recipients about this. The Waste Framework Directive introduced the obligation to notify such articles to the Scip database. Without system-to-system notification possibilities notifiers have to use the rather complicated IUCLID (cloud) software.

Based on our experience with SVHC issues and Scip notifications we have developed a practical training course in which we explain the main requirements and guide participants through their own IUCLID dossier creation.

Goal: being able to notify products to the Scip database using IUCLID.

### For whom?

For anyone that has a task in Scip notification. Our REACH & RoHS product compliance training course ([https://www.tenviro.eu/training\\_regulatory\\_product\\_compliance.php](https://www.tenviro.eu/training_regulatory_product_compliance.php)) is recommended to understand what articles and the SVHC candidate list are under REACH.

## Limitations

Before the training course participants must (based on information received from Tenviro) create an ECHA legal entity account (ECHA Cloud services), open IUCLID and upload the SVHC package. Participants must also gather article identifiers for one relevant article.

Note that there are many ways to identify and combine articles and future changes/ clarifications in requirements may require updating existing notifications. The training lays a foundation, participants will have to gain experience with what has been learned by using IUCLID, ECHA guidances and discussions with colleagues.
