Background

Many importers and manufacturers have registered their substances in accordance with REACH and reclassified them according to CLP. In addition, more and more substances are being included in REACH & CLP lists.

This affects all users of substances/ mixtures as well as importers/ manufacturers of articles due to:

- new safety data sheets, identified uses, exposure scenarios
- other labels, pictograms & H&P phrases with often more severe classifications and complications with regard to storage and use
- substances on the Authorisation, Restrictions or SVHC Candidate List.
